



UPCOMING GRANT OPPORTUNITIES

Our Center's grant applications open **March 3**, **2025!** There are two different tracks, each with their own eligibility criteria and priorities. The charts below include eligibility highlights, please note that complete eligibility requirements will be released upon formal application launches.

FRONTERA FARM AND FOOD BUSINESS GRANT

- Business must operate in one of the Center's 38 Priority Counties.
- Eligible applicants will receive focused technical assistance (TA) and coordination support from Center staff.
- Non-Competitive Process: Completing technical assistance and meeting other outlined requirements will factor into eligibility for grant funding toward a specific post-harvest project or business need.
- Zero or more years in business
- Awards of up to \$50,000

BUSINESS BUILDER FARM AND FOOD GRANT

- Open broadly to farmers and food businesses across Texas and New Mexico, with the exception of 53 counties in East Texas being served by the <u>Delta USDA Regional Food Business Center</u>.
- Competitive Request for Application (RFA) Process
- Funding can support a wide variety of approved post-harvest business needs.
- Must have been in business for a minimum of two years
- Gross revenue caps of \$500,000 for food producers and \$5,000,000 for food businesses.
- Awards of up to \$100,000
